- 1. The brief particulars of the Composite Scheme of Arrangement are as mentioned below:
  - a) The Composite Scheme of Arrangement of the Company was approved by the Hon'ble National Company Law Tribunal (NCLT) at Ahmedabad Bench vide its Order dated 27.11.2020.
  - b) Appointed Date: 01.04.2020
  - c) Effective date: 02.12.2020
  - d) Date of Allotment: 15.12.2020
  - e) Pursuant to the Composite Scheme of Arrangement amongst Infibeam Avenues Limited (formerly known as Infibeam Incorporation Limited), NSI Infinium Global Limited, Suvidhaa Infoserve Limited and DRC Systems India Limited and their respective Shareholders and Creditors as sanctioned by the Ahmedabad Bench of the Hon'ble National Company Law Tribunal; whereby upon coming into effect of the scheme and in consideration of the transfer and vesting of the "Themepark & Event software" undertaking from Infibeam Avenues Ltd into DRC Systems India Limited. DRC Systems India Limited shall issue and allot "1 fully paid up equity share of Rs.10/- each of DRC Systems India Limited for every 412 fully paid up equity shares of Re. 1/- each held in Infibeam Avenues Limited on the Record date."

Prior to the Scheme, the paid-up equity capital of DRC Systems India Limited was Rs. 2,25,00,000/- consisting of 22,50,000 equity shares of face value of Rs. 10/- each. After giving effect to the allotment of 16,15,356 equity shares of Rs. 10/- to the shareholders of Infibeam Avenues Limited, the post Composite Scheme of Arrangement paid-up equity capital of DRC Systems India Limited is Rs. 3,86,53,560/- consisting of 38,65,356 Equity shares Rs. 10/- each.
